



### AGREEMENT OF COLLABORATION

between the State Educational Institution of Higher Education in the Moscow Region "State University of Humanities and Technology" (Russian Federation) and Northern University LLC (Republic of Armenia)

The State Educational Institution of Higher Education in the Moscow Region "State University of Humanities and Technology" (Russian Federation), hereinafter referred to as "Party 1" represented by Interim Rector Yuri Eliseev acting on the basis of Order of the Minister of Education № 144-K dated 02.07.2020 on the one hand and Northern University LLC (Republic of Armenia) hereinafter referred to as "Party 2" represented by Rector Mher Makichyan acting on the basis of University Charter on the other hand

both called as "the Parties" have concluded the present Agreement as follows:

## 1. Subject of Agreement:

The subject of the present Agreement is collaboration in the sphere of scientific and methodological investigations and development of working plans defining the content and scope of cooperation between the Parties.

## 2. Basic directions of collaboration

- 2.1 The basic directions of collaboration are as follows:
- 2.1.1 Co-participation in international research and educational programs;
- 2.1.2 Conducting joint events according to agreed research and scientific-methodological directions;

- 2.1.3 Development and implementation of joint educational programs of higher education and additional education;
- 2.1.4 Arrangement of joint centers, laboratories, probation grounds;
- 2.1.5 Exchange of scientific workers and professors in order to conduct research in the directions of mutual concern;
- 2.1.6 Exchange of students, post-graduate students, arrangement of necessary conditions for development of theoretical and practical knowledge and for probation.
- 2.1.7 Exchange of experience and methodology of conducting classes, educational technologies;
- 2.1.8 Arrangement of joint centers, laboratories, probation grounds, conducting of joint conferences, seminars, round tables, summer schools, exhibitions on actual scientific and methodological problems;
- 2.1.9 Preparation of joint publications on actual issues.

# 3. Obligations of the Parties

- 3.1 The Parties pledge to:
- 3.1.1 Support the realization of joint projects and programs in the order, at the rate and by means of special agreements concluded of the present Agreement; fulfill juridical and fact actions necessary for the realization of joint projects;
- 3.1.2 Exchange information resources observing the national legislation.;
- 3.1.3 Discuss the issues connected with the realization of the directions of collaboration systematically;
- 3.1.4 Analyze the problems occurring in the process of the realization of the present Agreement, make agreed decisions on them;
- 3.1.5 Appoint the authorized representatives who have the right together with the Heads coordinate the collaboration.

### 4. Final Conditions

4.1. The concrete forms of collaboration between the Parties are stipulated in special agreements taking into consideration preferences of the Parties on all the aspects of activities.

- 4.2. The present Agreement is concluded without mutual financial conditions of the Parties. Financial conditions are stipulated in special agreements between the Parties.
- 4.3. The Parties provide the protection of rights for the results of intellectual activity as part of the realization of the present Agreement.
- 4.4. Any changes and additions of the conditions of the present Agreement are stipulated in special agreements, take effect since they are signed by both the Parties and are the integral part of the present Agreement.
- 4.5. The present Agreement remains valid for 5 (five) years since it is signed and renews every 5 (five) years till one of the Parties informs the other Party about the cancellation of Agreement in writing not later than 6 (six) months before the termination of the period of Agreement.
- 4.6. The present Agreement is made up in 4 (four) copies (2 (two) in Russian and 2 (two) in English), all having the same value. Two copies are given to each Party respectively.
